Privacy Policy: Cocoon Ibiza Pre Sale & Trip Competition

1. Introduction

This Privacy Policy explains how we collect, use, disclose, and protect personal information obtained through our ticket pre-sale entry process and participation in the Cocoon Ibiza Trip competition.

2. Information We Collect

When you participate in our ticket pre-sale entry and Cocoon Ibiza Ibiza Trip competition, we may collect the following information:

• Email Address: We collect your email address to provide you with priority access to tickets before general sale and to contact you regarding the competition.

3. How We Use Your Information

We use the collected information for the following purposes:

- Providing Priority Access: Your email address is used to grant you priority access to tickets during the pre-sale period.
- Competition Participation: Your email address may be used to notify you of your participation in the Cocoon Ibiza Ibiza Trip competition.
- Communication: We may use your email address to send important updates, announcements, and information related to the event and competition.
- Promotional Purposes: With your consent, you agree that both the event promoter and the venue (528 Ibiza) may contact you for marketing purposes via the communication methods provided.

4. Data Sharing

Your information may be shared with:

- Venue (528 Ibiza): We may share your email address with the event promoter for administrative purposes and to facilitate the ticketing process.
- Promoter (Cocoon Ibiza): Your information may be shared with the teams representing the promoter involved in the event for coordination and promotional activities.
- Competition Administration: In the case of the competition, your information may be shared with third parties involved in the administration of the competition prize.

5. Competition Terms

• By participating in the competition, you agree to the terms and conditions specified below. This may include details such as eligibility criteria, prize details, and redemption procedures.

6. Your Choices

• Opt-out: You can opt-out of receiving promotional emails by following the unsubscribe instructions provided in each email.

Competition Terms and Conditions: Cocoon Ibiza Ibiza Pre Sale & Trip Competition

Eligibility:

- 1.1 The "Cocoon Ibiza Ibiza Trip" competition (the "Competition") is open to individuals aged 18 years and older at the time of travel.
- 1.2 Employees, agents, and immediate family members of IRG or Cocoon are not eligible to participate in the Competition.

Entry Period:

- 2.1 The Competition entry period begins on 01 June 2024 and ends on 23 July 2024.
- 2.2 Entries received after the specified end date will not be considered.

How to Enter:

- 3.1 To enter the Competition and gain priority access to tickets for the Cocoon Ibiza event, participants must fill out the online entry form available at https://pages.viral-loops.com/cocoon-ibiza-2024
- 3.2 Only one entry per person is allowed. Unless using the reference share mechanic.

Winner Selection:

- 4.1 The winner will be selected at random from all eligible entries received.
- 4.2 The draw will take place on 23 July 2024 by the Cocoon team and the winner will be notified using the email address provided to the pre sale within 48 hours.
- 4.3 If the winner cannot be contacted or does not reply to claim the prize within 1 week of being contacted, an alternative winner will be selected.

Prize:

- 5.1 The prize for the Cocoon Ibiza Ibiza Trip Competition includes:
 - A trip for 3 people to Ibiza, staying at an Ibiza hotel for 3 nights over the dates of the Cocoon Ibiza event only.

10.1 The Cocoon Ibiza Ibiza Trip Competition and these terms and conditions are governed by the laws of the United Kingdom.

Limitation of Liability:

11.1 IRG or Cocoon shall not be liable for any issues related to the Competition beyond its reasonable control.

Awareness of Scammers:

12.1 Ibiza Rocks and Cocoon Ibiza caution participants to be vigilant of potential scammers who may attempt to contact entrants falsely claiming to represent the Competition. Official communication regarding the Cocoon Ibiza Ibiza Trip Competition will only be conducted through channels officially recognized and endorsed by 528 Ibiza or Cocoon.

- 12.2 Neither IRG, 528 Ibiza nor Cocoon Ibiza will be held liable for any consequences arising from unofficial communication, fraudulent attempts, or scams by third parties related to the Competition.
